## GENERAL INSTRUCTIONS & NOTICE OF EXISTENCE & PUBLIC NOTICE

- 1: The PMA (a **private membership association**) itself is a private banker by an individual banker as a private unincorporated banking association, a non-member of the Federal Reserve System, as Calafia Private Bankers, N.A. (CPBNA) also known as Calafia Private Bankers Association, aka Calafia Private Bankers, National Association, online, under a private tribal *de jure* government<sup>™</sup>, as CFO/CFO2/CFO3/CFO4/CFO5.
- 2: There is no need to record the existence of the **PMA** anyone, a PMA [Private Membership Association] is noted on every site and duly noted as anywhere because the most effective PMA for privacy purposes is a banking unincorporated association. For the benefit of any collaboration with a private contract upon any form of interaction. Any form of Violation by PMA is a \$50k Reatiner and \$10k per hour until the matter at issue is resolved.
  - The only purpose of documenting the acronym as “PMA” is protection. Any and all services dealing with any form of contract or service with ALL TLTN and sister companies are considered private-banking services of any form. Violation of that PMA where there are NO Refunds, dealing with all matters requested by third parties, whether for business or personally, including all matters outside de facto jurisdiction, are handled by clean hands and by our private, *de jure* unincorporated government<sup>™</sup> entities and private *de jure* Government Nation Association.
- 3: The PMA is governed by the terms and conditions of the Articles Private Unincorporated *de jure* Government<sup>™</sup>, Tribal Land Trust Nation<sup>™</sup> and private bankers as ‘individual banker/CFO is a private unincorporated bank as Calafia Bank & Trust<sup>™</sup>,’ aka CPBNA, by the PMA, the private *de jure* government entities of the TLTN Diplomat<sup>™</sup>/TLTN Diplomats, California *de jure* Assembly, Embassy, Calafia County, including MCTPEM that deals with ALL documents preparation throughout our entire community, serviced by all divisions of our nation secured under the Embassy with third-party LDA’s; secures all matters of our TLTN POSTAL AUTHORITY for any purchases of stamps secured under said PMA, all noted by Articles of Association. This also includes our Community Programs: All 4 U Recreatoinal Community Center, All 4 U Youth Sports, All 4 U Preparatory Academy, and so much more. Whereby Calafia Private Bankers, N.A. (CPBNA) has been required to be documented on public record.
- 4: **No** state can make any laws impairing the obligations of contracts, especially private contracts.
- 5: If the Trustee considers it necessary, the Trustee may publish a local legal notice as to the existence of the PMA. The wording is as follows: **Under Legal Notices:** “A Proclamation of existence of *de jure* Government<sup>™</sup>, Assembly, Embassy & the individual banker as private unincorporated bank Calafia Private Bankers, N.A.<sup>™</sup> hereby published by the Trustee MCT Withholding Agent.” Registration is allowed for the relationship of the PMA existence for the ‘Calafia Private Bankers, N.A. <sup>™</sup> ONLY...giving NO jurisdiction to any State. Situs: 07/29/2010: within Tiggie Province, Minor Outlying Island.
- 6: We have secured TLTN Diplomats verified by *National Identification & Liberty Travel Pass cards* for identification verification with AAMVA, TSA, DOS, OFM, etc...Coast Guards, etc... No one will be provided with our private terms and conditions of the PMA that is not contracted with the PMA, documented for record.
- 7: The Trustee is never compelled to share the terms and conditions of the PMA with any de facto court. All matters of the PMA are within the California De Jure Assembly Embassy Court.
- 8: The Trustee may form a private corporation/not for profit/foundation/humanitarian or other type of company that the PMA owns. The Trustee may apply for a 9-digit EIN # and work through the company as its manager only. The PMA owns the company for the Estate in Trust. The Trustee can also place a PMA into pure trust for extra protection. For the benefit of the people.
- 9: The Trustee, documented as Calafia Private Bankers, N.A. (CPBNA) is also the Fiduciary/Receiver is authorized to transfer assets, automobiles, etc... into a company name by title transfer owned by a PMA. We are self-insured and, when needed, will obtain an EIN # then it would be better to transfer assets, automobiles, etc... into the name of the company(s) the Tribal Land Trust Nation<sup>™</sup> as TLTN Diplomats<sup>™</sup> or what the PMA owns as of DOC 29<sup>th</sup> day of July 2010. [doc – date of creation]
- 10: The Trustee may transfer property, meaning real estate, into the company name or the Trust name by letter of intent with proper documents.
- 11: **All matters** are PMA contracts. All have been provided proper Notice.
